

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.workflora.com, and Luke Abmens Holdings Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Luke Abmens Holdings Inc. include www.workflora.com, WorkFlora LLC, www.workflora.com and www.simpleteachers.com. Collection of your Personal Information

In order to better provide you with products and services offered, Luke Abmens Holdings Inc. may collect personally identifiable information, such as your:

Sharing Information with Third Parties
